SUBJECT: INBOARD STRAP FITTING 212-010-103-101,

RECALL OF

HELICOPTERS AFFECTED: Serial numbers 30066, 30166, 30188, and 30297.

COMPONENTS AFFECTED: Inboard strap fittings 212-010-103-101 serial

numbers FF0002 through FF0047 inclusively.

COMPLIANCE: For affected strap fittings that have been installed;

before next flight.

For strap fittings that have not been installed; no later

than 7 days after the release date of this bulletin.

DESCRIPTION:




Figure 1. Inboard strap fitting 212-010-103-101.

Bell has been informed that some 212-010-103-101 inboard fittings have been incorrectly manufactured with the static stop lugs at an incorrect angle as shown in Figure 1. This ASB requires that the affected fittings be returned to Bell.

Applicability of this bulletin to any spare part shall be determined prior to its installation on an affected helicopter.

The engineering design aspects of this bulletin are FAA approved.

MANPOWER:

Approximately 12 man-hours are required to replace the inboard strap fittings if installed in a main rotor hub assembly. This estimate is based on hands-on time and may vary with personnel and facilities available.

- 2. If affected strap fittings have been installed, replace in accordance with the BHT-212-CR&O chapter 62.
- 3. Return all defective inboard strap fittings to Bell using the instructions detailed in the WARRANTY section.
- 4. If an affected inboard strap fitting had to be removed from a main rotor hub assembly, make an entry in the helicopter logbook (if applicable) and historical service records indicating compliance with this Alert Service Bulletin.
